


<u>FITTING INSTRUCTIONS FOR ECS0098BK ENGINE CASE SLIDERS</u> <u>GSX-S1000 & GSX-S1000FA '15- (LEFT HAND SIDE ONLY)</u>



Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – the rubber washers should be thrown away!





Left-hand side (as you sit on bike)

- Remove the three M6 bolts as positioned (arrowed) above. Ensure the sealing washer remains on the rear bolt hole.
- Insert new button head bolts with washers through the slider.
- Offer up to bike.
- Tighten evenly to manufactures specified torque.
- Fit bubble sticker as shown above.


INSTRUCTIONS DE MONTAGE POUR ECS0098BK - PROTECTION CARTER **MOTEUR**

Côté gauche (lorsque vous êtes sur la moto)

- Enlever les trois boulons comme positionnés (voir flèches) ci-dessus.
- S'assurer que les rondelles d'étanchéité restent solidaires boulons.
- Insérer les nouveaux boulons avec les rondelles.
- Insérer sur la moto
- Resserrer régulièrement aux couples de serrage recommandés.
- Appliquer les stickers comme indiqué ci-dessus.
