

FITTING INSTRUCTIONS FOR LP0062BK LICENCE PLATE BRACKET SUZUKI SV650 '07-



Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

- Remove seat, pillion seat and rear seat cowling (to remove cowling you will have to disconnect key operated pillion seat release wire from catch mechanism).
- Undo all plug connections and remove the tail unit.
- Undo and remove 2 bolts from either side which hold under-tray in position and gently unclip locators so under-tray may be allowed to drop slightly to give access to the OEM licence plate bracket bolts.
- Undo and remove 4 bolts holding OEM licence plate bracket from underneath.
- Drop OEM licence plate bracket down carefully until licence plate light wiring and indicator wiring is free.
- Take R&G plates and fix to bike using OEM bolts where the OEM tail unit was bolted to (note tapped holes face outwards with the radius end facing forward as shown below)





- Replace rear seat fairing/cowl (ensure to reconnect key operated pillion seat release wire to catch mechanism.
- If not already fitted, fit new licence plate light to new licence plate bracket and secure ensuring LED's are pointing so as to illuminate licence plate and wires are fed through the slot in new licence plate bracket and rubber gasket.



- We suggest cutting OEM wiring plug and connecting to new licence plate light using supplied connectors.
- If using OEM indicators, remove from OEM unit and fit to new licence plate bracket using supplied spacers and OEM nuts (please fit to same side as original).
- Place rubber gasket on mounting face of new tail-tidy.
- Take R&G tail tidy and offer up to bike and feed wires through into recess under seat.
- Fit to bike using the four 6mm button head allen bolts and washers using the tapped inserts in the plates that you have just fitted (note the bolts go through the gap left between the bodywork and under tray.
- Tighten all of the bolts.
- Reconnect all wiring plugs.
- Refit pillion seat.
- Refit riders seat.
- Check operation of all lights before use.
- Refit licence plate.
- IMPORTANT: IF FITTING A FULL-SIZE LICENCE PLATE AND PLACING IT FAR DOWN ON THE LICENCE PLATE HANGER, THERE IS A SMALL CHANCE OF THE LICENCE PLATE HITTING THE BACK WHEEL UNDER HEAVY LOAD AND OVER LARGE BUMPS IN THE ROAD. IT IS YOUR RESPONSIBILITY TO CHECK FOR THIS POSSIBILITY AND TAKE AVOIDING ACTION. FAILURE TO CHECK THIS COULD RESULT IN SERIOUS INJURY.

R&G RACING RETURNS POLICY (NON-FAULTY GOODS)

Returns must be pre-authorised (if not pre-authorised the return will be rejected). Goods may only be returned direct to us if they were purchased direct from us (customer must prove if necessary). Otherwise to be returned to original vendor. Goods must be in resellable condition, in the opinion of R&G Racing. All returns are subject to a 25% restocking and handling fee (25% of the gross value exc. P&P – at the prevailing price at time of purchase). The customer must pay any and all carriage charges. No returns of discontinued products, unless within 14 days of purchase. This policy does not affect your statutory rights and does not refer to faulty goods.
